February 5, 2026: Mennonite Church USA vs Homeland Security will have their appeals hearing in Federal Court in Washington DC. Jon Carlson, member of the MC USA Executive Board and Iris de León-Hartshorn, Executive Associate Director, will be attending the hearing. Our hope is that the denial for an injunction against immigration agents being on church property or entering inside for the purpose of conducting immigration raids will be over turned.
